
**MONTROSE TRUSTEE COUNCIL RESOLUTION REGARDING  
Funding for the Montrose Settlements Restoration Program:  
Restore Seabirds to San Nicolas Island**

1. The National Oceanic and Atmospheric Administration; the State of California acting through the State Lands Commission, the Department of Parks & Recreation and the Department of Fish & Game; and the Department of the Interior, acting through the U.S. Fish & Wildlife Service and the U.S. Park Service are the natural resource trustees (Trustees) for natural resources injured by releases of DDT and PCBs into the Southern California Bight.
2. Sums recovered in the civil action *United States, et al. v. Montrose Chemical Corp., et al.*, No. CV 90-3122-R (C.D. Cal. 1990) are being held in the Department of the Interior Natural Resource Damage Assessment and Restoration Fund (DOI Restoration Fund) and the registry account administered by the U.S. District Court for the Central District of California.
3. The Trustees have entered into a memorandum of agreement (MOA), as modified, that establishes a Trustee Council (Montrose Trustee Council) composed of one voting member for each trustee agency. Under the terms of that MOA, the Montrose Trustee Council is authorized to disburse funds for activities related to the damage assessment and restoration process.
4. The Trustees approve of funding Phase 2 of the feral cat elimination feasibility assessment as part of the project Restore Seabirds to San Nicolas Island. The goal of this project is to increase seabird colonies on San Nicolas Island by eliminating the non-native cat. A detailed description of work to be performed by Island Conservation is included in the attached Scope of Work (Attachment 1).
5. The Montrose Trustee Council resolves unanimously to authorize payment of \$53,421 to FWS from the DOI Restoration Fund to pay for the Phase 2 feasibility assessment as described in Paragraph 4 above. This amount corresponds to the estimated cost provided by Island Conservation. These funds will then be transferred to the U.S. Navy and added to the existing Cooperative Agreement between the Navy and Island Conservation for the cat removal project.
6. After completion of the work described in Paragraph 4 above, FWS will provide the Montrose Trustee Council with cost documentation that summarizes the costs incurred and includes copies of supporting documentation as required under the Trustees' cost reimbursement procedures. This documentation may be submitted

separately or as part of the annual cost documentation package that FWS is to provide for the annual advance MSRP funding received under a separate resolution. If a cost documentation package pertains to more than one funding resolution, it should clearly identify the resolutions for which it documents costs.
